LOCATION

Hill Street is situated in the heart of Edinburgh citycentre with direct access from Frederick Street and North Castle Street. George Street and Queen Street run parallel to Hill Street with Princes Street just a short walk away; all of which offer a wide range of shops, boutiques, bars, restaurants and cafés. Chaophraya, Browns, Côte Brasserie, Badger & Co., Rabble and The Queens Arms are all within a few minutes' walk. Nearby office occupiers include Walter Scott & Partners, Institute of Directors, Cazenove Capital and Office Space Scotland.

There are several public transport links close by, including multiple bus routes and tram stops on Princes Street. Both train stations, Haymarket and Waverley, are also within walking distance.

DESCRIPTION


15 Hill Street is Grade A listed and is located within the New Town Conservation Area and the UNESCO World Heritage Site.


The property is a striking Georgian townhouse built by James Hill between 1788-94. 15 Hill Street provides cellular office accommodation over ground, first, second and third floors benefitting from original features including cornicing and plaster wall panels on the first floor. The traditional timber sash and case windows provide fantastic levels of natural light, which is emphasised by the good floor to ceiling heights.
